The [Legal Food Hub](#) is a pro bono [referral network](#) that connects income-eligible food farmers, food entrepreneurs, and food-oriented nonprofits in

New England to the pro bono legal assistance that they need to thrive. The Legal Food Hub envisions a New England where local food and farm businesses thrive despite social, economic, climate, and environmental challenges. As the managing entity, the Legal Food Hub runs intake and confirms each applicant's eligibility for the program.
